

In the EIB, it is part of the Advisory Services and operates alongside and in coordination with other initiatives.


Step-by-step process guidance	throughout the entire FI life cycle, consistent with regulatory provisions, evidence-based practice and the realities of ESIF MAs.
Learning opportunities	to further the necessary understanding and skills in the market (studies, case studies, factsheets, videos, etc.).
Targeted awareness raising and networking	for MAs, the general public, potential bodies implementing FIs, private and public investors interested in co-investing, enterprises or for other potential final recipients.
Access to a single knowledge hub	to ensure (timely and targeted) availability of information and advice (FIs in my country, news and publications).


